- (f) Opening of bids: Bidders/agents need not to be present while opening of bids. Tender Opening Committee of the institute will open the bids internally. Subsequently Technical Committee of the institute will evaluate the bids. The lowest evaluated bidder (lowest of technically qualified bidder) as per recommendations of technical committee will be accepted in each case. Decision of technical committee/competent authority of this institute will be final and binding in this regard.

#### Eligibility of the tender documents

Following are the important points, for which a tender may be declared as "NOT ELIGIBLE" during the scrutiny:

- 1. Tenders submitted after due date and time.
- 2. Tenders submitted at some other place/department at ICMR-NARI, Pune instead of Purchase Department either after the due date and time, or reached some other place before due date and time but subsequently reached Purchase department after due date and time.

- 4. The tenderer has not agreed to give the required security deposit/performance bond, if asked.
- 5. the tenderer has not quoted for the entire requirement as specified.
- 6. The tenderer has not agreed to special conditions of the tender.
- 7. Tenders with conditional offers.
- 8. The tenderer who has furnished incomplete, incorrect or misleading information.
- 9. At the time of opening of Part-I, if a tenderer has included/mentioned price or any other charges in Part-I or has failed to submit Part-II separately in a sealed envelope.
- 10. The tenderer not complying to the warranty and AMC clauses as per tender terms, if any

#### Instructions to the Tenderer/Bidder for submitting the tender documents

- 1. Tenders are to be submitted in sealed envelopes super scribed with tender number, due date and time and clearly mentioning the name and address of the tenderer.
- 2. Technical Bid (Part-I) and Financial Bid (Part-II) should be kept in two separate sealed covers and both these covers again to be put in a single sealed cover and are required to be submitted within the specified due date and time.
- 3. Tenders should be deposited in the Inward Department, National AIDS Research Institute, G Block, Plot No:73, MIDC Bhosari, pune-411026 on or before due date and time as specified in the notice inviting tender.
- 4. An Earnest Money deposit as mentioned in the notice inviting tender are to be paid by Demand Draft in favour of "Director, NARI" payable at Bhosari, Pune-411026
- 5. Tenders received without paying EMD charges shall not be considered.
- 6. Each and every page of the technical offer as well as the financial offer to be signed by the bidder. No overwriting is permissible and such document having correction is liable to be rejected. However, cutting will be permissible on attestation by the authorized person
- 7. Discount offered should also be mentioned clearly in the bid.
- 8. Period of validity of bids: The bid should be valid/kept open for six months from the date of opening of the bid. Further, if extension of validity would be required in future, the bidder should extend the validity only and no other modifications shall be permitted.

#### **IMPORTANT NOTE:**

NARI shall not be responsible in any manner for late receipt of the tenders and/or EMD fee for whatsoever reason.



## **SCOPE OF WORK:**

#### 1) Eligibility:

- I. The laboratory must be NABL accredited.
- II. The bidder should have experience of at least three years with such Tie-up arrangement with Govt. / private hospitals or should have proven record of infrastructure and network to be able to provide such investigative service.
- III. The Company/ Firm which has been blacklisted/ debarred either by Tender Inviting Authority or by any State Government or Central Government Organization should not participate in the tender during the period of blacklisting.
- IV Instrument history files, calibration certificates, Vendor manuals & associated testings, Software verification & security of electronic data & records must be shared.

#### 2) Criteria for the selection:

The bidder has to quote the charges for all the listed investigations in the same order as given in the list (in Annexure-1). The following aspects will be considered while selecting the tenderer for the establishment of the annual rate contract.

- Lowest charges for the Investigations.
- 2. Distance: Centre should be nearer to NARI and NARI Clinics.
- Submission of Reports: Minimum time 02 days for submission of reports to respective clinics.
- 4. Infrastructure: Latest technology Equipment will be preferred.
- Technical Staff: Academic Qualifications and experience of Doctors,
   Medical/Para Medical staff will also be criteria of selection.
- 6. Legal Documentation/Certification: Legal permissions from the local Govt. authorities to run the hospital/ centre/ laboratory, approval/certificates regarding use of medical equipment etc. will strictly be considered for selection.
- 7. Performance Certificate: The bidder has to submit a list of Govt. / Private hospitals where such types of services are being catered for the last three years continuously along with list of investigations with rates and user's performance certificate for the last three years.

The tenders received will be evaluated by the Technical Committee based on the information provided by the Tenderer on the above mentioned points and asked in terms & conditions. The tenderers will have to mandatorily provide documentary proof for the same. No future correspondence in this regard shall be entertained once the tender is submitted.



#### 3) Bid Security/Earnest Money Deposit (EMD):

A Bid Security or Earnest Money equivalent to 2% of contract value must be furnished along with the tender in the form of Demand Draft from any nationalized Bank drawn in favor of the Director, ICMR-NARI, Pune payable at Pune. Bids, if received without Bid Security will summarily be rejected.

#### Refund of EMD

- EMD of the successful tenderer/bidder will be refunded after the Security
   Deposit/Performance bank guarantee as called for the contract is furnished.
- 2) EMD of unsuccessful bidder is whose technical bid has not been found suitable will be returned after award of contract.
- 3) EMDs/Security Deposits that remains unclaimed for consecutive three financial years will be forfeited and credited to the Govt. treasury.
- 4) No interest shall be payable on Bid Security/EMD/Security Deposit.
- 5) The startups and the vendors registered with Micro, Small and Medium Enterprises (Ministry of MSME) can get the exemption for payment of EMD who are having Udyyog Aadhar Memorandum Subject to furnishing of relevant valid certificate for claiming exemption.

#### 4) Performance Bank Guarantee:

(The successful bidder has to submit Security deposit/ Performance bank guarantee/ Contract Security – in the form of Demand Draft (in favour of the Director, ICMR-NARI) or Performance Bank Gurantee (PBG)- for 10% of the total contract value, within 14 days from date of LOA/LOI as per prescribed format enclosed at Annexure-IV.



#### 5) Collection of Samples:

- All collection material including gloves, vacutainers, needles will bw provided by ICMR-NARI.
- All the left over blood samples are required to be stored after sample processing.
   Selected laboratory will have to make arrangements to return the left over samples to ICMR-NARI.
- 3. A trained phlebotomist from the outsourced laboratory will have to be provided and will be stationed at the Model Colony Clinic (Shivaji Nagar, Pune), from 9 am to 4 pm from Monday to Friday. The outsourced laboratory will train their deputed phlebotomist on Universal biosafety precautions and good clinical and laboratory practices. It will also ensure Hepatitis B vaccination of the phlebotomist. In case of accidental exposure during collections in the ICMR-NARI clinic, the outsourced laboratory will provide necessary investigations and treatment to the phlebotomist. ICMR-NARI is not liable for any claim against same from the phlebotomist or the outsourced laboratory.
- 4. In order to maintain the confidentiality as an ethical consideration, samples will be sent with code numbers, age, sex and relevant clinical history of the participants. The Patient and study participants name will not be mentioned along with sample as well as on report. Patients/Study participants will be identified by study code only.
- 5. Reports to be sent at the earliest before 24 hours by soft copy and signed and s ealed hard copies with 2 days of collection.
- 6. Daily one or two rounds for the sample collection at respective study clinic site (Model Colony Clinic (Shivaji Nagar, Pune), Gadikhana Clinic (Dr. Kotanis Arogya Kendra, Shukrawar peth, Pune), NARI Clinic (NARI, Bhosari, Pune) will be required. The timing for these rounds will be communicated with selected laboratory after the agreement as per study requirement at that time.



- 7. Number of Patients and Study participants expected to be investigated:
  - i. **For referral clinic.** Approx. 2000 to 2500 Participants are expected to be investigated in a short time period of 6 months.
  - ii. **For studies.** Approx. 500 participants expected to be screened within 2 years. The number may vary according to approval received for different studies within that period.
- 8. The Successful Tender shall make his own arrangement at his cost to get the samples collected from site to selected laboratory in cold chain under aseptic precaution.

## **Terms & conditions:**

- 1) The Contract will initially be awarded for a period of one year and canbe extended based on performance certificate from the competent authority after completion of one year.
- 2) The contract can be terminated at any time by Director, NARI by giving one months' notice.
- The Tenders must have necessary in house facilities (at the quoted Lab premises) in respect of latest technology & technical knowhow to carry out the Lab investigations round the clock for which rates are being quoted. All the tests quoted for should mention whether itis conducted in-house or outsourced. In case of outsourced investigations, the details of laboratory to which the investigation is to be outsourced must be provided in the Technical Bid.
- The methodology and the time period after which the report will be provided should be mentioned for each investigation. A status report on the infrastructure facilities available with the tender submission in support of its technical capability to execute the quoted Lab investigations must accompany the empanelment submission highlighting details of equipment, type of procedure and details of qualification & experience of manpower, whether full time of procedure and details of qualification & experience of manpower, whether full time or part-time engaged for the conduction the quoted investigations, quality control measures, and automation in various sections of laboratory.
- In case the firm to whom the contract is awarded, fails to provide the service, the institute shall have the right to encash the Bank Guarantee provided by the firm.

  No correspondence/conference in this regard will be entertained.
- 6) The tenderer shall have to mention its name and address (along with the telephone, Fax, Mobile numbers) for all future communications and shall be the sole signatory of the quotation.



- 7) The tenderer must undertake at the time of applying for empanelment submission that it has perused the terms and conditions of the tender submission and the same are acceptable to them. Any conditional acceptance shall make tender submission liable for rejection.
- 8) All investigations must be quoted separately, even when a test is part of the profile / package of two or more tests. All components of the profile package are to be quoted separately also along with quoting the profile / package rate separately.
- 9) The evaluation of technical bid will be based on presence of trained manpower, automation, infrastructure along with latest technology presence of in-house facility and maximum time taken to provide the reports.
- 10) If the performance is found not to be satisfactory, NARI reserves the right to terminate the contract at any time.
- 11) In case of any dispute, the decision of the Director, NARI shall be final and binding on both the parties, and jurisdiction will be Pune for all the disputes.
