- 1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 8. Packing:

The packing shall be sufficient t o withstand, without limitation, rough handling during transit and exposure to extreme temperatures, **salt**, **and** precipitation during **transit and** open storage. **Packing case** size and weights **shall** take into consi deration, where appropriate, the remoteness of the Goods, **final destination** and the absence **of heavy** handling facilities at all points in transit

- (d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follo ws;(i) The venue of Arbitration shall be the place from where the contract is issued and the language of the ar bitration proceedings and that of all councils and communications between the parties shall be English.
- (ii) The decision of the majority of arbitrators shall be final and binding upon parties.
- (iii) Settlement of disputes through pre-institution mediation and settlement in accordance with the comm ercial courts, commercial division and commercial appellate division of High Courts (Amendment) Act 2018, No. 28 of 2018 Chapter IIIA.
- (e) Settlement of Disputes: Notwithstanding any reference to arbitration herein, a. the parties shall continu e to perform their respective obligations under the Contract unless they otherwise agree; and The Procure ment agency shall pay the Supplier any monies due to the Supplier.
