1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Submission of SLA and ATC Adherence Certificate

The Service Provider shall submit their certificate of adherence to the Service L evel Agreement (SLA) and the Acceptance of Terms and Conditions (ATC) of the Government e-Marketplace (GeM) bid.

2. Procurement for District Level Sentient Survey (DLSS)

- (a) The participants (bidders) are notified that this procurement is being conducted for the District Level Sentient Survey (DLSS) of the Indian Council of Medical Research National Institute of Traditional and Village Areas Research (ICMR-NI TVAR), Pune.
- (b) The designated districts for the DLSS survey are Mumbai, Mumbai-Suburban, Pune, Thane, Dhule, and Satara in Maharashtra.
- (c) The vehicle procured under this bid shall be deployed in the aforementioned districts of Maharashtra as per the timeline and duration instructed by the Study Principal Investigator (PI), Site PI, or Local Site In-charge.

3. Maintenance of Confidentiality

The Service Provider must ensure that the integrity and confidentiality of inform ation and project data are maintained under all conditions. Any breach of this o bligation shall attract appropriate legal actions.

4. Submission of One Bid per Bidder

- (a) A firm may submit only one bid, either individually or as part of a joint venture.
- (b) If a firm submits more than one bid, either individually or as part of a joint v enture, all bids in which that firm is involved will be disqualified.

5. Right to Cancel the Bid

The Indian Council of Medical Research (ICMR) reserves the right to cancel the b id, in whole or in part, without assigning any reason or liability on the buyer. The decision of the Director, ICMR-NITVAR, Pune, in such cases, shall be final and binding.

6. Goods and Services Tax (GST)

GST will be applicable as per the latest Government of India (GoI) notification.

7. Settlement of Disputes

- (a) If any dispute or difference arises between the Procurement Agency and the Supplier in connection with or arising out of the contract, the parties shall make every effort to resolve it through mutual consultation.
- (b) If the parties fail to resolve the dispute within thirty (30) days of such consult ation, either party may give notice to the other of its intention to commence arb itration. No arbitration may begin unless such notice is given.
- (c) Any dispute or difference for which arbitration has been requested shall be finally settled by arbitration. Arbitration may be commenced either before or after the delivery of goods under the contract. Disputes between the Purchaser/Consignee and a domestic Supplier shall be referred to a sole arbitrator appointed by the Director, ICMR-NITVAR, Pune.
- (d) Arbitration proceedings shall be conducted as follows:
- (i) The venue of arbitration shall be the location where the contract was issued, and the language of proceedings shall be English.
- (ii) The decision of the majority of arbitrators shall be final and binding on the p arties.
- (iii) Disputes shall also be subject to pre-institution mediation and settlement in accordance with the Commercial Courts (Amendment) Act, 2018, No. 28 of 2018, Chapter IIIA.
- (e) Notwithstanding any arbitration proceedings, both parties shall continue to p erform their contractual obligations unless otherwise agreed. The Procurement Agency shall pay the Supplier any due payments.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

Category item bunched with it.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
