Tender Inviting Authority

This GeM tender is for procuring Comprehensive Maintenance Services for the BSL-3 Facility at ICMR-NITVA R, Pune. It is issued by the Director, ICMR - National Institute of Translational Virology and AIDS Research (NITVAR), Pune, Maharashtra, as per the specifications outlined in the attached ATC document.

Bid Security Declaration

As per Rule 170 of GFR 2017, Micro and Small Enterprises (MSEs) defined in the MSE Procurement Policy of the MSME Department and recognized Startups by DPIIT are exempt from EMD payment. Such bidders mu st provide a certified copy of valid registration details. The exemption applies only to the trade group and monetary value of registration.

Eligibility

Bidders must submit an undertaking confirming their eligibility to participate in this tender and certifying t echnical expertise to provide Comprehensive Maintenance Services for the BSL-3 Facility.

One Bid per Bidder

Each firm may submit only one bid, either individually or as part of a joint venture. Submitting multiple bid s will result in disqualification of all bids involving the firm.

Right to Cancel

ICMR-NITVAR reserves the right to cancel this bid in full or part without assigning any reason. The Director' s decision will be final and binding.

Payment Terms

- Payment (100%) will be made upon receipt and acceptance of goods/services and submission of a v alid Performance Bank Guarantee (PBG).
- Payment is subject to statutory deductions, taxes, liquidated damages, and non-rectification of defe cts.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

9. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

10. Past Project Experience
