8. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 10. Buyer Added Bid Specific ATC (Additional Terms and Conditions)**1. Tender Inviting Authority**

1.1 This tender enquiry for procurement of one (01) unit of Microplate Reader is invited by the Director, ICMR - National Institute of Translational Virology and AIDS Research (NITVAR), Pune , Maharashtra, in accordance with the technical specifications provided in the Specification P DF attached under the ATC document.

2. Bid Security Declaration

2.1 Bid Security shall be applicable as per Rule 170 of GFR 2017.

2.2 Micro and Small Enterprises (MSEs) registered under the MSME Procurement Policy and Startups recognized by DPIIT (refer para 1.11.2-4(a)) are exempted from submission of EMD, subject to submission of valid registration certificates.

2.3 The exemption shall be applicable only for the registered trade group and monetary limit

3. Eligibility Criteria

3.1 The bidder shall be either:

(a) The Original Manufacturer, or

(b) An Authorized Agent of the manufacturer (authorization to be enclosed).

4. One Bid per Bidder

4.1 A bidder shall submit only one bid, either individually or as a partner in a joint venture.

4.2 Submission of more than one bid by the same firm shall result in disqualification of all such bids.

5. Right to Cancel

5.1 ICMR-NITVAR reserves the right to cancel the bid process, partly or fully, at any stage, without assigning any reason or incurring any liability.

5.2 The decision of the Director, ICMR-NITVAR shall be final and binding.

6. Inspection and Testing

6.1 ICMR-NITVAR or its authorized representative reserves the right to inspect and/or test the goods to verify conformity with contractual specifications.

6.2 The supplier may conduct independent quality testing at its own cost.

7. Acceptance Certificate

7.1 Inspection shall be carried out by an authorized representative of ICMR-NITVAR.

7.2 An Acceptance Certificate shall be issued upon satisfactory inspection.

8. Packing

8.1 The supplier shall provide adequate and secure packing to prevent damage during transit.

8.2 Packing shall ensure:

(a) Protection against rough handling, extreme temperatures, moisture, salt, and precipitation;

(b) Compliance with technical specifications, marking, and documentation.

8.3 Packing and marking shall be subject to inspection prior to dispatch.

9. Payment Terms

9.1 100% payment shall be released after receipt, inspection, acceptance of goods, and submission of a valid Performance Bank Guarantee (PBG).

9.2 Payment shall be subject to statutory deductions, liquidated damages, and penalties, if any.

9.3 The following documents shall be submitted for payment processing:

(a) Copy of Purchase Order;

(b) Copy of Extension Order, if applicable;

(c) Original Invoice with contract details;

(d) Acknowledgement of receipt issued by the consignee;

(e) Performance Bank Guarantee.

10. Performance Bank Guarantee

10.1 Performance Bank Guarantee shall be furnished as per GeM Bid conditions.

11. Settlement of Disputes

11.1 Disputes shall be resolved amicably through mutual consultation.

11.2 If unresolved within 30 days, arbitration may be initiated.

11.3 Arbitration shall be conducted by an Arbitrator appointed by the Director, ICMR-NITVAR.

11.4 Venue: Pune, Maharashtra; Language: English.

11.5 Arbitration shall be governed by the Commercial Courts (Amendment) Act, 2018.

11.6 The arbitral award shall be final and binding.

11.7 Both parties shall continue to perform contractual obligations during arbitration.

12. Insurance

12.1 The supplier shall insure the goods against all risks during transportation, storage, and delivery.

12.2 Insurance shall be valid for three (03) months after delivery.

12.3 Insurance shall be extended at the supplier's cost if commissioning is delayed beyond three months, unless delay is attributable to the consignee.

12.4 Insurance shall cover 110% of the contract value, from supplier's warehouse to consignee's site.

13. Liquidated Damages

13.1 Liquidated damages at 0.5% of contract value per week, subject to a maximum of 10%, shall be levied for delay.

13.2 Applicable taxes/GST on liquidated damages shall be deducted from supplier's dues.

14. GST

14.1 GST shall be applicable as per prevailing Government of India notifications.

15. Definition of Delivery

15.1 Delivery shall include supply, installation, testing, and commissioning at ICMR-NITVAR, Pune.

16. Make in India (MII) Policy

16.1 Bidders shall submit details of local content and compliance with the Make in India (MII) Policy.

17. Contract Splitting

17.1 Contract splitting is not applicable in this tender.

18. Technical Compliance

18.1 The bidder shall submit point-by-point technical compliance supported by datasheets, brochures, or website links.

18.2 The specifications mentioned in the attached Specification Document under ATC shall prevail over GeM product parameters.

19. Precedence of Buyer Added ATC

19.1 The provisions of this Buyer Added Bid Specific ATC shall override all other bid conditions.

20. Delivery Location

20.1 Delivery, including installation, testing, and commissioning, shall be at ICMR-NITVAR, Pune.

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

5. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

6. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

7. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

Additional Clause For Annual Maintenance Charges

1. AMC charges to be indicated as percentage of cost of Product/Equipment quoted for each year after the warranty period.

2. GST shall be included in the AMC Charges quoted.

3. The AMC functionality shall be available in bid only and no direct RA shall be applicable. In case of bid to RA decrement rules shall be applicable on total price inclusive of AMC charges.

3.1 Buyer shall indicate number of years of warranty by selecting option of 1- 10 Years available in the field depending on warranty parameter applicable in category parameters for the equipment. The Seller while participating in Bid/RA will get fields to indicate AMC charges as percentage depending on number of years of AMC selected by Buyer. The following shall be applicable If 5 year AMC selected.

3.1.1 AMC charges for first year after warranty period – Percentage to be indicated- A1.

3.1.2 AMC charges for second year after warranty period – Percentage to be indicated A2.

3.1.3 AMC charges for third year after warranty period – Percentage to be indicated A3.

3.1.4 AMC charges for fourth year after warranty period – Percentage to be indicated A4.

3.1.5 AMC charges for 5th year after warranty period – Percentage to be indicated A5.

3.2 The calculation of AMC Charges shall take in to account of number of years of warranty and duration of AMC as specified while creating bid.

3.3 AMC charges to be indicated for each subsequent year should be same or higher than preceding year.

3.4 The AMC charges shall be offered within range of 3 to 25% of cost of equipment.

4. Since AMC charges are to be paid only later for each year during AMC period , applicable performance guarantee amount after placement of contract shall be based on the cost of product/equipment and not on basis of cost of equipment along with AMC Charges.

5. Performance bank guarantee applicable for AMC is to be submitted at start of the AMC and shall be applicable as 2.5% on the total contract value including AMC Charges The PBG submitted after award of contract shall be released only after new PBG for the AMC period is submitted and accepted by buyer/consignee after due verification. Bank guarantee for AMC is to remain valid till completion of AMC period plus one year .The bank guarantee for AMC shall be submitted to buyer directly.

6. In case of splitting of quantity product/equipment cost and AMC charges offered by L-1 in the evaluated cost shall be matched by higher quoting eligible bidders on one to one basis .The equipment cost shall be matched and AMC charges shall be matched year to year.

7. The AMC Contract shall be an offline contract to be handled by buyer. The payment of AMC will be made on AMC frequency (as indicated above) basis after satisfactory completion of said period, duly certified by end user and scope of AMC will be as per para 1 above.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
