If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

2. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior

written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Buyer-Added ATC Clauses (Numbered)

1. Tender Inviting Authority

1.1 This GeM tender pertains to the procurement of Comprehensive Maintenance Services for the BSL-3 Facility at ICMR-NITVAR, Pune.

1.2 The tender is issued by the Director, ICMR-National Institute of Translational Virology and AIDS Research (NITVAR), Pune, Maharashtra, in accordance with the specifications detailed in the attached Additional Terms and Conditions (ATC) document.

2. Bid Security Declaration

2.1 As per Rule 170 of GFR 2017, Micro and Small Enterprises (MSEs) as defined under the MSE Procurement Policy of the MSME Department, and startups recognized by DPIIT, are exempt from payment of Earnest Money Deposit (EMD).

2.2 Such bidders shall submit a certified copy of valid registration documents.

2.3 The exemption shall be applicable only for the registered trade group and the monetary limit specified in the registration.

3. Eligibility

3.1 Bidders shall submit an undertaking confirming their eligibility to participate in the tender.

3.2 Bidders shall certify their technical competence and experience to provide Comprehensive Maintenance Services for a BSL-3 Facility.

4. One Bid per Bidder

4.1 Each bidder is permitted to submit only one bid, either independently or as part of a joint venture.

4.2 Submission of multiple bids by the same firm shall result in disqualification of all such bids.

5. Right to Cancel

5.1 ICMR-NITVAR reserves the right to cancel the bid, in full or in part, at any stage without assigning any reason.

5.2 The decision of the Director, ICMR-NITVAR shall be final and binding.

6. Payment Terms

6.1 Payment of 100% shall be made after receipt and acceptance of the services and submission of a valid Performance Bank Guarantee (PBG).

6.2 Payments shall be subject to applicable statutory deductions, taxes, liquidated damages, and penalties for non-rectification of defects, if any.

7. Documents Required for Payment Processing

7.1 Copy of the Purchase Order.

7.2 Copy of Extension Order, if applicable.

7.3 Original invoice indicating contract details.

7.4 Acknowledgement of receipt of services from the consignee.

7.5 Performance Bank Guarantee.

8. Performance Bank Guarantee (PBG)

8.1 Performance Bank Guarantee shall be applicable as per GeM bid conditions.

9. Settlement of Disputes

9.1 Disputes shall first be resolved through mutual consultation.

9.2 If unresolved within 30 days, the matter shall be referred to arbitration.

9.3 The arbitrator shall be appointed by the Director, ICMR-NITVAR.

9.4 Venue of arbitration shall be Pune, Maharashtra, and proceedings shall be conducted in English.

9.5 Arbitration shall be governed by the Commercial Courts (Amendment) Act, 2018.

9.6 Contractual obligations shall continue during the pendency of arbitration proceedings.

10. Liquidated Damages

10.1 Delay in delivery or performance shall attract liquidated damages at the rate of 0.5% of the contract

value per week or part thereof, subject to a maximum of 10% of the total contract value.

10.2 Applicable GST or other taxes shall be deducted accordingly.

11. Goods and Services Tax (GST)

11.1 GST shall be applicable as per the latest notifications issued by the Government of India.

12. Debarred Firms

12.1 Bidders listed on the World Bank Debarment List shall be ineligible to participate in this tender.

13. Definition of Delivery

13.1 Delivery shall include supply, installation, testing, and commissioning of the equipment and services at ICMR-NITVAR, Pune.

14. Make in India (MII) Policy

14.1 Bidders shall declare the percentage of local content in their offering.

14.2 Details of collaboration with Indian firms shall be provided in compliance with the Make in India policy.

15. Contract Splitting

15.1 Contract splitting is not applicable for this tender.

16. Technical Compliance

16.1 The conditions specified in the Buyer-Added Bid Specific ATC shall prevail.

16.2 Bidders shall submit a point-by-point compliance statement against the technical specifications, supported by data sheets, brochures, or relevant website links.

16.3 The technical specifications provided in the attached ATC document shall override the product specification parameters available on the GeM portal.

17. Location Details

17.1 The BSL-3 Facility is located within the premises of ICMR-NITVAR, Pune.

18. Service and Support Requirements

18.1 The Bidder/OEM shall have a dedicated or toll-free telephone number for service support.

18.2 An escalation matrix with contact details for service support shall be provided.

19. Manpower Requirements

19.1 The Service Provider shall have at least 30% of the required manpower on its payroll for a minimum period of one year.

19.2 Documentary evidence in support of the above shall be uploaded by the bidder for verification by the buyer.

19.3 Such manpower shall form part of the total manpower to be deployed upon award of the contract.

20. Certificates

20.1 Non-submission of any certificate or document required under the bid document, ATC, or corrigendum, if any, shall render the bid liable to rejection.

21. Payment of Salaries and Wages

21.1 The Service Provider shall initially pay salaries and wages to the deployed staff from its own resources.

21.2 Reimbursement shall be claimed from the buyer along with statutory documents such as PF, ESIC, and bank statements evidencing payment to staff.

22. Precedence of Buyer-Added ATC

22.1 The terms and conditions stipulated in the Buyer-Added Bid Specific ATC shall take precedence over all other bid documents and conditions.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा। In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
