8. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Tender Inviting Authority

1.1 This tender enquiry for the procurement of one (01) unit of EMBASE DATABASE SUBSCRIPTION is invited by the **Director, ICMR - National Institute of Translational Virology and AIDS Research (NITVAR), Pune, Maharashtra**, in accordance with the technical specifications provided in the **Specification PDF** attached under the ATC document.

2. Bid Security Declaration

2.1 Bid Security shall be applicable as per **Rule 170 of the General Financial Rules (GFR), 2017.**

2.2 **Micro and Small Enterprises (MSEs)** registered under the MSME Procurement Policy and **Startups recognized by DPIIT** (refer Para 1.11.2-4(a)) are exempted from submission of Earnest Money Deposit (EMD), subject to submission of valid registration certificates.

2.3 The exemption shall be applicable only for the registered trade group and within the prescribed monetary limits.

3. Eligibility Criteria

3.1 The bidder shall be either:

- (a) The **Original Manufacturer**, or
- (b) An **Authorized Agent** of the manufacturer (manufacturer's authorization letter to be enclosed).

4. One Bid per Bidder

4.1 A bidder shall submit only one bid, either individually or as a partner in a joint venture.

4.2 Submission of more than one bid by the same firm shall result in **disqualification of all such bids**

5. Right to Cancel

5.1 **ICMR-NITVAR** reserves the right to cancel the bid process, partly or fully, at any stage, without assigning any reason and without incurring any liability.

5.2 The decision of the **Director, ICMR-NITVAR** shall be final and binding.

6. Inspection and Testing

6.1 ICMR-NITVAR or its authorized representative reserves the right to inspect and/or test the goods to verify conformity with contractual specifications.

6.2 The supplier may conduct independent quality testing at its own cost.

7. Acceptance Certificate

7.1 Inspection shall be carried out by an authorized representative of ICMR-NITVAR.

7.2 An **Acceptance Certificate** shall be issued upon satisfactory inspection.

8. Packing

8.1 The supplier shall provide adequate and secure packing to prevent damage during transit.

8.2 Packing shall ensure:

- (a) Protection against rough handling, extreme temperatures, moisture, salt, and precipitation;
- (b) Compliance with technical specifications, marking, and documentation requirements.

8.3 Packing and marking shall be subject to inspection prior to dispatch.

9. Payment Terms

9.1 **100% payment** shall be released after receipt, inspection, acceptance of goods, and submission of a valid **Performance Bank Guarantee (PBG)**.

9.2 Payment shall be subject to statutory deductions, liquidated damages, and penalties, if any.

9.3 The following documents shall be submitted for processing of payment:

- (a) Copy of the Purchase Order;
- (b) Copy of Extension Order, if applicable;
- (c) Original Invoice with contract details;
- (d) Acknowledgement of receipt issued by the consignee;
- (e) Performance Bank Guarantee.

10. Performance Bank Guarantee

10.1 The Performance Bank Guarantee shall be furnished as per **GeM Bid conditions**.

11. Settlement of Disputes

11.1 Disputes shall be resolved amicably through mutual consultation.

11.2 If unresolved within thirty (30) days, the matter may be referred to arbitration.

11.3 Arbitration shall be conducted by an Arbitrator appointed by the **Director, ICMR-NITVAR**.

11.4 The venue of arbitration shall be **Pune, Maharashtra**, and the language shall be **English**.

11.5 Arbitration proceedings shall be governed by the **Commercial Courts (Amendment) Act, 2018**.

11.6 The arbitral award shall be final and binding on both parties.

11.7 Both parties shall continue to perform their contractual obligations during the arbitration proceedings.

12. Insurance

12.1 The supplier shall insure the goods against all risks during transportation, storage, and delivery.

12.2 Insurance coverage shall remain valid for **three (03) months after delivery**.

12.3 In case commissioning is delayed beyond three months, insurance shall be extended at the supplier's cost, unless the delay is attributable to the consignee.

12.4 Insurance shall cover **110% of the contract value**, from the supplier's warehouse up to the consignee's site.

13. Liquidated Damages

13.1 Liquidated damages at the rate of **0.5% of the contract value per week**, subject to a maximum of **10%**, shall be levied for delay in delivery or completion.

13.2 Applicable taxes/GST on liquidated damages shall be deducted from the supplier's dues.

14. Goods and Services Tax (GST)

14.1 GST shall be applicable as per prevailing **Government of India** notifications.

15. Definition of Delivery

15.1 Delivery shall include **supply, installation, testing, and commissioning** at **ICMR-NITVAR, Pune**.

16. Make in India (MII) Policy

16.1 Bidders shall submit details of local content and compliance with the **Make in India (MII) Policy**.

17. Contract Splitting

17.1 Contract splitting shall **not** be applicable in this tender.

18. Technical Compliance

18.1 The bidder shall submit **point-by-point technical compliance**, supported by datasheets, brochures, or website links.

18.2 The specifications mentioned in the **Specification Document attached under ATC** shall prevail over GeM product parameters.

19. Precedence of Buyer Added ATC

19.1 The provisions of this **Buyer Added Bid-Specific ATC** shall override all other bid conditions.

20. Delivery Location

20.1 Delivery, including installation, testing, and commissioning, shall be at **ICMR-NITVAR, Pune**.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
