1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a

certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

8. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Buyer Added Bid Specific ATC

BUYER ADDED BID SPECIFIC ATC

1. Tender Inviting Authority

This tender is issued by the Director, ICMR-National Institute of Translational Virology and AIDS Research (NITVAR), Pune, Maharashtra, for procurement of the specified consumable(s), as per the technical specifications detailed in the Specification Document attached under the Buyer Added Bid Specific ATC.

2. Bid Security Declaration

In accordance with Rule 170 of the General Financial Rules (GFR), 2017, the Bid Security Declaration shall be applicable.

MSEs registered under the applicable MSME Procurement Policy and DPIIT-recognized Startups shall be exempt from submission of EMD, subject to fulfillment of the applicable eligibility conditions and submission of valid supporting documents, wherever applicable.

3. Eligibility Criteria

The bidder shall be either:

- The Original Equipment Manufacturer (OEM)/Original Manufacturer of the offered consumable(s); or
- An authorized distributor/dealer/agent of the OEM/Original Manufacturer.

Where the bidder is not the OEM/Original Manufacturer, a valid authorization certificate issued by the OEM/Original Manufacturer shall be submitted along with the bid, wherever applicable.

4. One Bid per Bidder

Each bidder shall submit only one bid against this tender. Submission of multiple bids by the same bidder, either directly or indirectly, may result in disqualification in accordance with the applicable GeM terms and conditions.

5. Right to Accept, Reject or Cancel the Tender

The Director, ICMR-NITVAR reserves the right to accept or reject any bid and/or cancel the tender, in whole or in part, at any stage, in accordance with applicable Government rules, procurement guidelines and GeM terms and conditions.

6. Inspection and Testing

ICMR-NITVAR or its designated representative reserves the right to inspect and/or test the supplied consumables, wherever considered necessary, to verify conformity with the prescribed specifications, quality requirements, quantity, batch/lot details, shelf life and other contractual requirements.

The supplier shall provide all necessary assistance and relevant documentation required for such inspection and/or testing.

7. Acceptance of Supplies

The supplied consumables shall be subject to inspection and verification upon receipt at ICMR-NITVAR.

Acceptance shall be accorded only after verification of the quantity, specifications, quality, packaging, batch/lot details, expiry date/residual shelf life and other prescribed requirements.

Any material found to be damaged, defective, expired, short-supplied, incorrectly supplied or otherwise not conforming to the prescribed specifications shall be liable for rejection and replacement by the supplier at no additional cost to ICMR-NITVAR.

8. Shelf Life

The consumables supplied shall have the minimum residual shelf life specified in the Specification Document at the time of delivery.

The supplier shall ensure that no expired or short-dated material is supplied without prior written approval of ICMR-NITVAR.

9. Packing and Transportation

The consumables shall be suitably packed to protect them from damage, contamination, deterioration, moisture, temperature variation and other risks during handling, transportation and storage.

The supplier shall ensure that the packaging complies with applicable statutory, regulatory and manufacturer requirements.

The material shall be delivered to the consignee location specified in the GeM Contract.

Where the nature of the consumable requires specific transportation or storage conditions, the supplier shall ensure compliance with such conditions throughout transportation and delivery.

10. Replacement of Defective/Damaged Material

Any consumable found to be defective, damaged, contaminated, deteriorated, expired, short-supplied or otherwise not conforming to the prescribed specifications shall be replaced by the supplier at no additional cost to ICMR-NITVAR.

The replacement shall be made within the period specified by ICMR-NITVAR.

11. Payment Terms

100% payment shall be released after successful delivery, inspection and acceptance of the consumables by ICMR-NITVAR and submission of all required documents, subject to applicable statutory deductions.

The following documents shall be submitted for processing of payment, as applicable:

- a. Copy of Purchase Order/GeM Contract;
- b. Tax Invoice;
- c. Delivery Challan/Consignee Receipt;
- d. Inspection/Acceptance Certificate, wherever applicable; and
- e. Any other document required under the GeM Bid/Contract.

12. Performance Bank Guarantee (PBG)

Performance Bank Guarantee shall be applicable as per the terms and conditions specified in the GeM Bid/Contract and applicable Government rules.

13. Liquidated Damages

In the event of delay in delivery attributable to the supplier, Liquidated Damages shall be levied in accordance with the provisions of the applicable GeM Contract, subject to the maximum permissible limit prescribed therein.

14. GST and Other Taxes

GST and all other applicable taxes, duties, levies and statutory charges shall be governed by the prevailing Government of India rules and regulations.

Unless specifically provided otherwise in the GeM Bid, the rates quoted by the bidder shall be inclusive of all applicable charges up to the consignee location.

15. Blacklisted/Debarred Firms

Bidders who, as on the date of bid submission, are blacklisted, debarred, suspended or otherwise prohibited from participating in procurement by any Government Organization or by the GeM Portal shall be ineligible to participate in this GeM Bid.

The bidder shall comply with all applicable declarations and requirements prescribed under the GeM terms and conditions in this regard.

16. Delivery

The complete quantity of the consumables shall be delivered at the following consignee location:

The complete supply shall be delivered within the delivery period specified in the GeM Contract.

17. Make in India (MII) Policy

The bidder shall comply with the applicable provisions of the Government of India Make in India (MII) Policy and other applicable Government procurement policies, as amended from time to time.

18. Technical Compliance and Documents

The bidder shall submit the following documents along with the bid:

- a. Point-wise compliance against each specification mentioned in the attached Specification Document;
- b. Product catalogue/brochure/data sheet, wherever applicable;
- c. OEM/Manufacturer Authorization Certificate, wherever applicable;
- d. Details of make, model, product code/catalogue number, wherever applicable; and
- e. Any other supporting technical literature or document specifically required under the bid.

Failure to submit the required technical documents may result in the bid being considered non-responsive, subject to applicable GeM provisions.

19. Discrepancy Between GeM Bid and Specification Document

In the event of any discrepancy, inconsistency or conflict between the specifications mentioned in the GeM Bid and those specified in the Specification Document attached under the Buyer Added Bid Specific ATC, the provisions of the Specification Document shall prevail, to the extent permissible under applicable GeM t

terms and Government rules.

20. Contract Splitting

Contract splitting shall not be applicable for this tender. The complete quantity shall be considered as one procurement requirement and shall be supplied in accordance with the GeM Contract, subject to applicable GeM provisions.

21. Dispute Resolution

Any dispute arising out of or in connection with the contract shall, in the first instance, be resolved amicably through mutual consultation between the parties.

In the event that the dispute cannot be resolved amicably, the same shall be dealt with in accordance with the applicable contractual provisions, GeM terms and conditions and applicable laws of India.

The jurisdiction for arbitration and/or legal proceedings, to the extent permissible under the applicable contractual provisions, shall be **Pune, Maharashtra**.

22. Precedence of Buyer Added ATC Conditions

In the event of any discrepancy or inconsistency between the standard GeM Bid Terms and Conditions and the conditions specified in this Buyer Added Bid Specific ATC, the provisions of this Buyer Added Bid Specific ATC shall prevail to the extent permissible under the applicable GeM terms and conditions and Government rules.

23. Compliance with Statutory and Regulatory Requirements

4. Mandating submission of documents (other than EMD and signed Integrity Pact - which can be submitted within 5 days of bid opening) in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service

Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
